In January 2015, 2 years after the initial opening of TEHO EuRope bv, a 100% subsidiary of TEHO International Inc, TEHO EuRope bv continues to expand their European operation with the acquisition of LIHA bv and Store Rijnmond bv. For the testing of lifeboats and davits, other test weights and calibrated load cells are available. Next to the above, they provide periodic cargo gear surveys and quinquennial surveys. Overhaul, repair and testing of blocks can also be carried out in the well-equipped workshop in Rotterdam.
